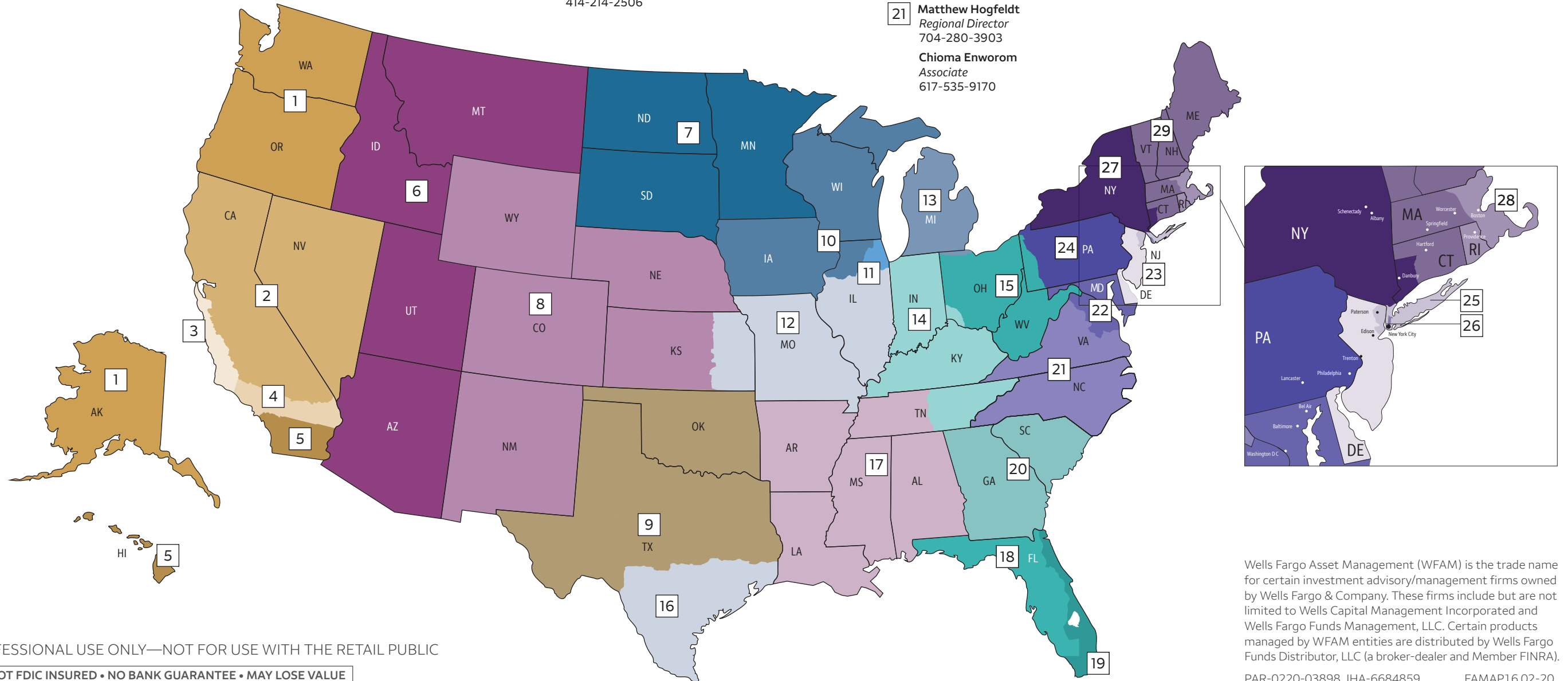


# Integrated Distribution Territory Map
