Competitive advantages

- Fundamental, all-cap research: Conducting rigorous, bottom-up research across the market-capitalization spectrum provides powerful insights and an informational advantage that supports the team's efforts to identify the most attractive investment opportunities.
- Continuous risk management and a strict sell discipline: These are critical elements ingrained in the team's investment process, given that fast-growing companies often command premium valuations and can be prone to higher volatility.

Brokerage commissions, stamp duty fees, interest, taxes, acquired fund fees and expenses (if any), and extraordinary expenses are excluded from the expense cap. Prior to or after the commitment expiration date, the cap may be increased or the commitment to maintain the cap may be terminated only with the approval of the Board of Trustees. Without this cap, the fund's returns would have been lower. The expense ratio paid by an investor is the net expense ratio (the total annual fund operating expenses after fee waivers) as stated in the prospectus.
