THE FUND

The Allspring Short-Term Bond Plus Fund seeks current income by investing primarily in a diversified portfolio of fixed-income securities with an average maturity of less than three years.

FUND STRATEGY

- Strives to outperform the Bloomberg U.S. 1-3 Year Government/Credit Bond Index by investing in corporate bonds and structured products while maintaining a duration target of approximately one to two years.
- Seeks to typically hold large exposures in spread sectors, including allocations to short-term corporate debt, residential and commercial mortgage-backed debt, and asset-backed securities.
- Uses a relative-value approach based on extensive credit analysis that seeks opportunities from changing market trends and pricing inefficiencies to generate excess returns.

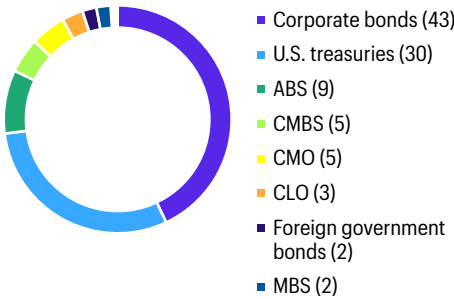

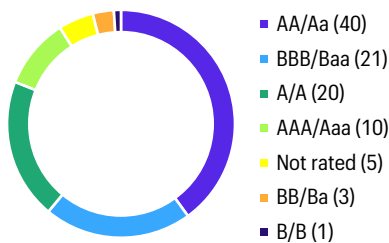
Competitive advantages

The manager has contractually committed through 12-31-2024, to waive fees and/or reimburse expenses to the extent necessary to cap the fund's total annual fund operating expenses after fee waivers at 0.61%(A), 1.36%(C), 0.29%(I) and 0.24%(R6). Brokerage commissions, stamp duty fees, interest, taxes, acquired fund fees and expenses (if any), and extraordinary expenses are excluded from the expense cap. Prior to or after the commitment expiration date, the cap may be increased or the commitment to maintain the cap may be terminated only with the approval of the Board of Trustees. Without this cap, the fund's returns would have been lower. The expense ratio paid by an investor is the net expense ratio (the total annual fund operating expenses after fee waivers) as stated in the prospectus.

¹ The Morningstar RatingTM for funds, or star rating, is calculated for managed products (including mutual funds, variable annuity and variable life subaccounts, exchange-traded funds, closed-end funds, and separate accounts) with at least a three-year history. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. It is calculated based on a Morningstar risk-adjusted return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. The Morningstar Rating does not include any adjustment for sales loads. The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star. The Overall Morningstar Rating for a managed product is derived from a weighted average of the performance figures associated with its 3-, 5-, and 10-year (if applicable) Morningstar Rating metrics. While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent 3-year period actually has the greatest impact because it is included in all three rating periods. Across U.S. domiciled Short-Term Bond funds, the Allspring Short-Term Bond Plus Fund received 3 stars among 534 funds, 4 stars among 494 funds, and 4 stars among 359 funds for the 3-, 5-, and 10-year periods, respectively.
